#### Other Discussion:

- A) Proceed with the engineering inspection and evaluation of the West Dike.
- B) Continue repair on the trash rack supports. (with DEM approval)
- C) Explore options for a low-growth perennial ground cover for the dam and get approval from DEM.
- D) Determine if the \$65,000 budgeted for rip-rap work is necessary.
- E) Investigate the possibility of getting power to the dam area to aid in watering any new vegetation.
- F) The West dike issue is highlighted, with a bulge observed and engineering work budgeted for potential repairs.
